The meeting was called to order by Mr. Edwards. Mrs. Carter conducted the roll and a Quorum was declared present.

Upon a motion by Mr. Probst, duly seconded by Mrs. Allen to approve the minutes of the February 27, 2023, regular meeting. Motion carried unanimously.

Upon a motion by Mr. Probst, duly seconded by Mr. Bachus to approve purchase orders, bank statements, and bank reconciliations as reported. Motion carried unanimously.

Upon a motion by Mr. Parker, duly seconded by Mrs. Allen to approve the Secretary/Treasurer and Bookkeeper to attend the Center for Local Government Excellence training on March 15, 2023 in Baton Rouge. Motion carried unanimously.

Upon a motion by Mrs. Allen, duly seconded by Mr. Parker to approve the President to sign a time extension request letter and a revised environmental review document for Frye Magee for CDBG Public Facilities. Motion carried unanimously.

Jurors brought forward the following Ordinance Violations:

Mr. Whittington – The ordinance needs to be checked for the violation at 873 Eagle Rd not picking up certified letter that was sent out over 30 days ago. Also, a letter needs to be sent to the Concordia Sewer notifying them that 421 Rountree has a hole in the ditch that is full of sewage, and the manhole on Eagle Rd. is not pumping properly and is full of sewage.

Mr. Neal – A letter needs to be sent the Sewer district notifying them that the sewer line at 170 Crestview was located by Entergy and it needs to be fixed.

A motion was made by Mr. Probst, duly seconded by Mr. Neal to cite the above violations motion carried unanimously.

Under Project/Grant Updates Interim Secretary/Treasurer Cathy Darden provided the following updates: RFQ Engineering Proposal Packets have been placed on the Police Jury's website, as well as emailed to Engineering firms, the packets must be turned in to the Secretary/Treasurer by 10:00 a.m. on April 6, 2023. Mrs. Darden also advised the jury that she has spoken to an engineering firm to get a contract signed facility planning for approval.

Mr. Whittington –Sage Rd. needs gravel and Rountree has a big rut on the shoulder near Morace Rd. that needs to be repaired.

Mr. Adams – 246 Gore Rd. the ditch is holding water and needs to be spread out. Flaherty Rd. needs a sign.

Clay Gravel (yards) – 15yds on Como.

Culverts – 24"x32' on BJ Rd., 18"x31' on Temple Rd., and 18"x38' on Temple Rd.
