



Waste Pro which indicated its desire to continue the contract for a two year period, however only with an increase in the per household fee. He stressed that the solid waste and finance committees should meet as soon as possible in order to make a final decision before September 30, 2017. He also gave an update on the transition period for the position of secretary treasurer with Ms. Sandi Burley. Mr. Friloux's report was accepted as presented.

A motion was then made by Mr. Parker seconded by Mr. Dunbar to refer the Waste Pro proposals to the solid waste and finance committees for review and recommendation with consideration of bidding out the contract. Motion carried.

A motion was made by Mr. Probst seconded by Mr. Parker to approve Ordinance No. 2017-01 establishing a speed limit on Centennial Road as follows:

**ORDINANCE NO. 2017-01**

**AN ORDINANCE OF THE PARISH OF CONCORDIA , LOUISIANA  
AMENDING THE CONCORDIA PARISH CODE OF ORDINANCES,  
CHAPTER 14, ARTICLE I. SEC. 14-4 (a).**

**WHEREAS**, the Concordia Parish Police Jury desires to keep residential areas free of speeding vehicles which endanger lives and property; and

**WHEREAS**, the Concordia Parish Police Jury has received complaints with speeding along Centennial Road in Vidalia, Louisiana; and

**WHEREAS**, it is in the best interest of the property owners in the neighborhood of Centennial Road to establish a speed limit on said Centennial Road; therefore

**BE IT ORDAINED** by the Concordia Parish Police Jury, State of Louisiana, that the Code of Ordinances be amended by adding the following to this Section of said ordinance:

Sec. 14-4 (a). Centennial Road, Twenty-Five (25) Miles Per Hour.

**AND BE IT FURTHER ORDAINED** that the police jury's department of public works properly post the speed limit as adopted.

And the vote thereon was as follows: Yays 5 Nays 0 Absent 4 Abstain 0

And the ordinance was declared adopted in regular session held this 11<sup>th</sup> day of September, 2017 and becomes effective immediately.

A motion was made by Mr. Jernigan seconded by Mr. Dunbar to approve payment to A & M Engineering, LLC for services performed on Minorca Road emergency repairs in the amount of \$480. Motion carried.

A motion was made by Mr. Dunbar seconded by Mr. Probst to approve a request of the LSU Ag Center to hold its Annual 4-H Pet Show on the Old Courthouse Square. Motion carried.

A motion was made by Mr. Parker seconded by Mr. Probst to approve the tabled matter of the request of the Village of Ridgecrest to assist in repairs to Happy Lane and Willow Drive with the understanding that the work be done on days off and at the discretion of the superintendent with time permitting. Motion carried.

A motion was made by Mr. Parker to approve the work request of the Delta Charter School. A short discussion ensued and Mr. Parker rescinded his motion. A motion was then made by Mr. Jernigan seconded by Mr. Parker to request a letter from the principal of Delta Charter be sent with a hold harmless clause and the work requested to be done at the discretion of the superintendent. Motion carried.

A motion was made by Mr. Dunbar seconded by Mr. Probst to approve the Annual Safety Meeting in December at the Duck's Nest. Motion carried.

A motion was made by Mr. Parker seconded by Mr. Dunbar to ratify the purchase orders as presented. Motion carried.

A motion was made by Mr. Jernigan seconded by Mr. Dunbar to approve Superintendent's Material & Work Request as follows: 28 yards of washed gravel for Bodark Road, 28 yards of washed gravel and 56 yards of pit run gravel for Como Road, 21 yards of washed gravel for Bee Brake Road, 14 yards of washed gravel for Country Meadows and clearing a cross ditch off Hammett Addition. Motion carried.

Mr. Austin Lipsey, assistant district attorney, advised the jury of problems in reactivating the Black River Lake Commission. He is continuing his efforts. He did advise that even though the commission may be reactivated, the problems of enforcing parish ordinances will likely continue. The jury accepted his report without further action.

A motion was made by Mr. Jernigan seconded by Mr. Parker to cite the property owned by Cheryl Lowry at 218 Levens Addition and the property between 113 and 161 Levens Addition in violation of the parish nuisance ordinance due to high grass, weeds and debris. Motion carried.

There being no further business a motion was made by Mr. Parker seconded by Mr. Dunbar that the meeting be adjourned. Motion carried.
